



THE COMMUNITY

The City of Yuba City is a diverse, flourishing rural community located in Sutter County just 40 miles north of Sacramento. It is bordered on the east by the beautiful Feather River, while the City's western horizon is dominated by the Sutter Buttes, popularly believed to be the smallest mountain range in the world.

Founded in 1849 during the Gold Rush era, the City comprises 15 square miles and has a population of approximately 68,000 residents. Its unique blend of urban amenities and small-town charm has made it the agricultural, economic and social center of the Yuba-Sutter Region. Its tree-lined downtown serves as the perfect backdrop for shopping, dining, entertainment and community events. While Yuba City is home to hundreds of industrial, retail, and commercial businesses, its historic agricultural roots continue to play an important role in the local economy. The area surrounding Yuba City is one of the most productive agricultural regions in the world. Other major components of the economy include manufacturing, food processing facilities, and Beale Air Force Base.

The City enjoys many natural and physical assets including an attractive climate, excellent healthcare facilities and quality public and private schools. Higher education facilities include Yuba Community College, along with three universities that are within an hour's drive: University of California, Davis; Sacramento State University; and Chico State University. Yuba City residents and visitors enjoy excellent outdoor activities such as hiking, bird watching, boating, fishing, hunting, biking, and waterskiing. Other recreational areas, such as the San Francisco Bay Area and the Tahoe Donner Region are within a comfortable driving distance.

Yuba City's unique location offers a quality, familyoriented lifestyle including affordable housing and well-planned growth. The City prides itself on its well-maintained parks and recreation programs, offering a wide range of recreational activities for the entire family, including beautiful parks and a state-of-the-art aquatic center. The diverse population of Yuba City is a source of pride for its citizens. The Punjabi population in the Yuba-Sutter area has grown to be one of the largest in the United States and one of the largest Sikh populations outside of India. Each year on the first Sunday of November, Sikhs throughout the world attend the Sikh parade in Yuba City.

THE ORGANIZATION

Incorporated in 1908, the City of Yuba City is a full-service General Law City. Yuba City operates under the Council-Manager form of government, with each of the five Council members elected at-large and serving four-year, staggered terms. From among its members, the Council selects the City's Mayor and Vice Mayor every year. The City Council appoints a full-time City Manager whose job is to carry out the Council's policy directives and coordinate, control and direct City operations, functions and projects.

Municipal services include police and fire protection, water and sanitation services, construction and maintenance of streets and infrastructure, planning and zoning, economic development, recreational activities and cultural events, and general administrative/support services. The FY 2017-18 General Fund budget of \$41.3 million funds 303.5 full-time positions.

City Management and staff work well together, which contributes to a healthy working environment. Yuba City is a unique city in that it has five Commissions (Planning, Parks and Recreation, Economic Development, Senior, and Youth) that were created to advise the City Council on specific issues.

- Enhance our Image/Reputation


THE DEPARTMENT


The Development Services Department is responsible for functions related to development, the evolution of the City, enhancement, and preservation. Areas of responsibility include:

THE POSITION


The Planning Manager is responsible for managing the staff engaged in the full range of government planning services. Under direction from the Development Services Director, the Planning Manager leads, oversees and reviews current and advanced planning projects and/or issues from original submission through to final approval at the Planning Commission or City Council level, and provides highly complex staff assistance to the Director or their designee.

The new Planning Manager will be highly engaged and will direct and supervise the work of subordinate professional planners and front counter staff involved in planning projects, research, urban planning analyses and design, and code development. Some of the essential functions of the position include supervising and coordinating the investigation of complex or difficult zoning matters and preparing reports and recommendations regarding ordinance interpretation and modification; providing information and assistance to developers, property owners and other members from the public concerning the laws, regulations, standards, policies and procedures related to permissible uses of property, submission of plans, processing of applications, subdividing and other zoning and land use issues; and serving as staff liaison to the Planning Commission, ad hoc planning committees and City Council subcommittees.

The ideal candidate will be well versed in all aspects of contemporary urban planning including excellent urban design skills and will be an advocate for continuous improvement. He/she will be a successful manager of people who derives satisfaction from mentoring and developing subordinates through continuous improvement in the planning process. The new Planning Manager must be a forward thinking manager who anticipates opportunities and challenges and an adept critical thinker and problem solver who embraces complex challenges.

The Planning Manager will also be an outstanding communicator with exceptional interpersonal skills who displays impressive versatility interacting with a wide variety of audiences and stakeholders. A well-developed political









acumen and the ability to facilitate sound decision-making will be expected as well.

Yuba City is a wonderful community that offers an outstanding combination of qualityof-life attributes coupled with a small town ambiance - a great place to become part of the fabric of the community you serve.

A Bachelor's degree from a four-year college in planning, architecture, or other design

related field, urban studies, environmental planning, public administration, political science, economics, or closely related field is required as is four years of recent increasingly responsible full time professional experience in urban planning, including two years in a supervisory role. A Master's degree and/or AICP are desirable.
